**EXPLANATION OF DONATIONS TO
THE GARDEN CLUBS OF ILLINOIS, INC. 2023-2024**

Donations sent directly to Lincoln Memorial Garden, local scholarship funds, Nature Conservancy, etc. are not GCI donations. Membership in the Lincoln Memorial Garden Foundation should be sent directly to Springfield and should **not** be included on this form.

GCI PRESIDENT'S PROJECT 2023-2024 – Supports the GCI President's project for her/his 2-year term.

STATE FLOWER SHOW – Donations are continuous to ensure sufficient funds will be available for the State Flower Show.

SCHOLARSHIP–Donations help provide scholarships to students in any horticulture-related field at any accredited Illinois college or university.

GCI SCHOOLS/CONFERENCES/SYMPOSIUMS – Donations are used to secure speakers for the GCI schools, conferences, and symposiums. All members may attend these schools, conferences, and symposiums.

GCI GRANTS – All garden clubs are eligible for grants with qualified activities.

BLUE/GOLD STAR MEMORIAL MARKERS – Donations are used to help clubs defray the cost of installing and maintaining the markers, which honor those who have served in the U.S. Military.

GARDEN THERAPY – Donations are used to initiate and maintain garden therapy programs in institutional settings.

HISTORIC PRESERVATION/RESTORATION – Donations are used to preserve or restore historic sites.

NGC PROJECTS – Donations are used to support NGC projects. Check the NGC website at **gardenclub.org** for a current listing.

ROADSIDE OPERATIONS AND WILDFLOWERS – Donations are used to help clubs defray the cost of wildflowers and roadside plantings in their communities.

WORLD GARDENING/NATURAL DISASTERS – Donations are used to provide aid for areas devastated by natural disasters.

YOUTH ACTIVITIES – Donations are used to fund programs for Youth Gardeners.

LINCOLN MEMORIAL GARDEN'S LANDSCAPE RESTORATION ENDOWMENT FUND – Donations are invested and the interest is used to fund landscape maintenance projects.

LINCOLN MEMORIAL GARDEN'S CHILDREN'S WOODLAND GARDEN – Donations are used to enhance and expand the children's garden at the Lincoln Memorial Garden.
